Sidewalks shall meet TDLR requirements. *If proposed sidewalks are 4' in width, then 5 ft. x 5 ft. landings are required every 200 feet.* 

During construction, notify Guadalupe County at co.guadalupe.tx.us at least 48 hours in advance of any work to be performed within County ROW. Such notification is also required before implementing any approved traffic control plans on existing county-maintained roads. Full closure of county roads requires at least one month advance notice and is subject to the discretion of the County Engineer and possible approval by Guadalupe County Commissioners Court per Transportation Code, Chapter 251.

### **EXCAVATION PERMIT FOR INSTALLATION OF UTILITY**

THIS EXCAVATION PERMIT is effective from and after the date of the last signature set forth below and is by and between GUADALUPE COUNTY, TEXAS, a political subdivision of the State of Texas (the "County") and \_\_\_\_\_\_("Company").

The \_\_\_\_\_\_ will be constructed and maintained on County Right-of-Way as shown on the attached Exhibit "A" and pursuant to the direction of Guadalupe County in accordance with governing laws and other guidelines followed by the Guadalupe County Road and Bridge Department relative to maintenance of County Right-of-Way property.

Construction by Company shall be conducted in such a manner as to minimize disruption of the normal flow of traffic and comply with proper traffic control measures as set forth in applicable portions of the Texas Manual of Uniform Traffic Control Devices as required by the Uniform Act Regulating Traffic on Highways (V.C. X 6701d).

Company agrees to perform construction in a good and workmanlike manner with no cessation except for causes beyond Company's reasonable control. This Agreement shall be cancellable at any time after one year at County's option upon giving company 30 days' notice of its intent to cancel this Agreement.

Company will install its \_\_\_\_\_\_, that inference or encroachment on already existing utility infrastructure is minimized. Company will cooperate with adjacent landowners' to minimize inconvenience caused by its construction activities.

All obligation of Company set forth herein shall be at the sole cost, risk and expense of Company.

It is expressly understood that Guadalupe County does not purport hereby to grant any right, claim, title or easement in or upon this Right-of-Way. It is further understood and agreed that Guadalupe County may require Company to relocate its \_\_\_\_\_\_\_ at Company's sole cost, risk and expense, subject to provisions of governing laws, by giving 90 days' written notice to Company.

County shall provide Company with adequate road Right-of-Way easement with which to relocate its line.

Company agrees, warrants and guarantees that it will be responsible for any damage to any part of the roadway or County Right-of-Way.

In the event that Company fails to comply with any or all of the requirements set for herein, the County may take such action as it deems appropriate to compel compliance.

Company shall, during Construction and thereafter, restore the County Right-of-Way to equal or better conditions after completion of any work.

Company acknowledges that its signatory hereto has full and complete authority to execute this Excavation Permit.


