Further, the County has an opportunity, within 30 days after the above dated notification, to examine all information on file and submit a written opinion from the Commissioners Court stating any findings, conclusions, or other information that the Commissioners Court considers important to the TCEQ's final determination.

The TCEQ will not render a final decision on the above referenced application until after the receipt of Commissioners Court comments or upon the expiration of the 30-day submission period, whichever is earlier.
