NOTICE OF APPLICATION AND PRELIMINARY DECISION FOR TPDES PERMIT FOR MUNICIPAL WASTEWATER

RENEWAL

PERMIT NO. WQ0015334001

APPLICATION AND PRELIMINARY DECISION. Cibolo Creek Municipal Authority, P.O. Box 930, Schertz, Texas 78154, has applied to the Texas Commission on Environmental Quality (TCEQ) for a renewal of Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0015334001, which authorizes the discharge of treated domestic wastewater at an annual average flow not to exceed 3,000,000 gallons per day. TCEQ received this application on September 3, 2019.

The facility is located at 7424 Trainer Hale Road, in Bexar County, Texas 78154. The treated effluent is discharged directly to Mid-Cibolo Creek in Segment No. 1913 of the San Antonio River Basin. The designated uses for Segment No. 1913 are primary contact recreation and limited aquatic life use. The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. TCEQ holds a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.
