Application and Preliminary Decision. Waste Management of Texas, Inc., 1700 Kohlenberg Road, New Braunfels, Texas, a solid waste management company, has applied to the Texas Commission on Environmental Quality (TCEQ) for a permit modification to authorize the deletion of one landfill unit and reshaping of another in the Mesquite Creek Landfill. The facility is located at 1700 Kohlenberg Road in Comal and Guadalupe Counties, Texas. This application was received by the TCEQ on March 4, 2021. The TCEQ executive director has completed the technical review of the application and has prepared a draft permit modification. The draft modification, if approved, would establish the conditions under which the facility must operate. The executive director has made a preliminary decision that this permit modification, if issued, meets all statutory and regulatory requirements. Please be aware that any contact information you provide, including your name, phone number, email address and physical address will become part of the agency's public record. After the deadline for public comments, the executive director will review and consider the comments. The executive director is not required to file a response to comments. If approved, notice of issuance will be mailed to everyone who submitted public comments or requested to be on the mailing list for this application. If comments are received, the mailing will also provide an explanation of the opportunity to file a motion to overturn the executive director's decision.
